WHEREAS, In reference to College Rule 2.8, Santa Fe College is committed to maintaining a

work and education environment free of discrimination and harassment with respect to race, ethnicity, creed, color, religion, age, disability, sex (including pregnancy, gender identity, and sexual orientation), marital status, national origin, genetic information, political options or affiliations, and veteran status;

and,

WHEREAS, Students of various affiliations, backgrounds, ages, gender, and ability believe

that every person should be allowed to express themselves in the manner that

matches their gender identity; and,

WHEREAS, Recently passed legislation in several states violates the policies of Santa Fe

College and contradicts the values of the student body; and,

WHEREAS, Student Government can and should seek to affect positive change for its

students and our community; therefore,

BE IT RESOLVED, That the students of Santa Fe College reaffirm their support for College Rule 2.8 and the guarantee of student rights provided in Article I, Section 5 of the Constitution of the Student Body of Santa Fe College, and accordingly urge the immediate repeal of laws, ordinances, and regulations that violate those rights, such as HB2 in North Carolina and HB1523 in Mississippi.

BE IT RESOLVED, That Santa Fe College should, in all possible instances and with all feasible means, for students of any gender identity: protect against harassment and discrimination in all forms, provide inclusive and supportive services for transitioning students, and ensure equal access to facilities for students of all gender identities;

BE IT FURTHER RESOLVED, That Student Government and its associated organizations should not enter into new partnerships with programs, conferences, associations, or other agreements that support discriminatory acts on the basis of sex, including gender identity and sexual orientation;
